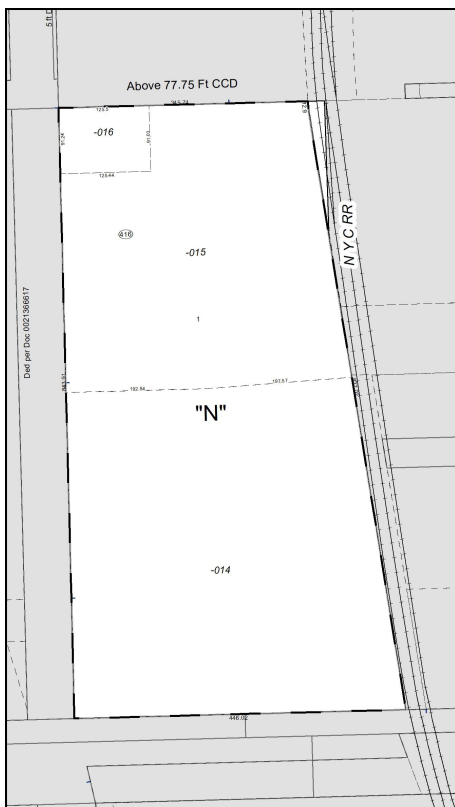
Building: 421, Floor: 1.0



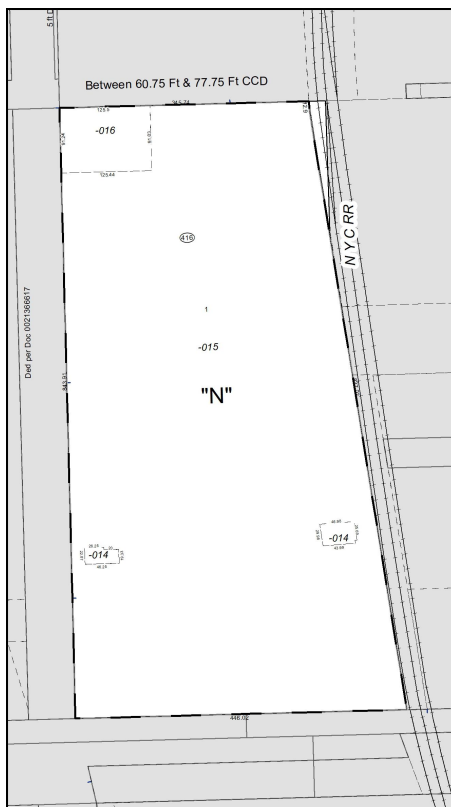

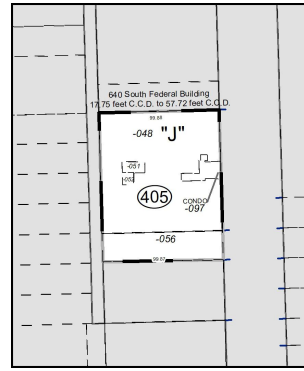
Building: 423, Floor: 4.0



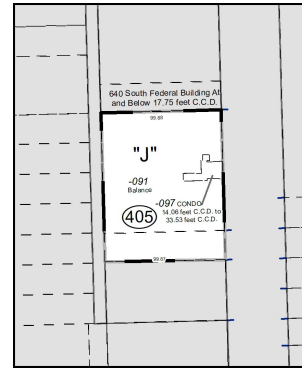
