Dear Mr. Wilkin:

In response to your recent request, please be advised that the subject property is zoned Residential Planned Development Number 583 ("PD 583"), as amended. In response to the legibility of the PD ordinance, you may wish to check the City Clerk's web site for the appropriate 1995 and 1996 City Council journals. They may contain more legible copies.

You are also seeking an opinion on potential pitfalls you might face before submitting for a building permit. According to the drawings and survey you submitted, the subject property is improved with a 2 story, frame single family home and frame garage. You are proposing to add a 42 square foot, rear addition to the ground floor kitchen, demolish the existing deck and garage, and construct a new garage with deck above and car port below. The proposed addition will result in a reduction in the rear setback only, from 31'-9" to 29'-6".

We cannot confirm that all setbacks, easements, accessory building heights, floor area, etc. satisfactorily meet the requirements of the PD without a complete building permit application. Upon our receipt of the building permit application, we will review the PD to ensure that there is allowable floor area remaining for the proposed 42 square foot addition and that the project complies with the PD.

Dear Mr. FitzGerald:

The Department of Planning and Development has considered your request on behalf of the Applicant, C.A. Development, for a minor change to Residential Planned Development No. 583, as amended, Subarea C, and hereby approves your request pursuant to the authority granted by Section 11.11-3© of the Chicago Zoning Ordinance and Statement No. 14 of Residential Planned Development No. 583, as amended.

In your letter dated November 4, 1997, you requested that the Site Plan originally approved by the Chicago City Council on October 30, 1996 be modified to reflect a reduction in the minimum rear yard setback requirement for this proposed single-family home located on lot 84 within Subarea C of the Planned Development. Specifically, you requested a reduction in the rear yard setback from the required 5'-11 3/4" to a proposed distance of 2'-0 1/8" measured from the rear property line to a portion of the proposed attached garage, and to a proposed distance of 2'-11 3/8" measured from the rear property line to a portion of the proposed single-family home. This modification is depicted on the Site Plan for Subarea C prepared by FitzGerald Associates Architects, dated October 6, 1997. Please note that this proposed construction will be the final stage of development for Residential Planned Development No. 583, as amended.

In your letter dated November 4, 1997, you indicated that this modification is necessitated by the projection of a bay window designed for the front facade. In an effort to maintain the required front yard setback, the proposed building was shifted further to the





rear of the property thereby encroaching into the required rear yard setback. Beyond the required board on board fence that will run along the rear of the subject property is the adjacent Chicago & Northwestern Railway line. Since the requested change will occur in an area not visibly obvious to adjacent property owners, and since open space for this house is located in the northern side yard area, the Department of Planning and Development has determined that this modification will not change the residential character of this development nor have any adverse impact on the surrounding area.

With regard to your request, the Department of Planning and Development has determined that the modification would constitute a minor change pursuant to Section 11.11-3 © of the Chicago Zoning Ordinance and Statement No. 14 of Residential Planned Development No. 583, as amended.

Accordingly, pursuant to the authority granted by the Chicago Zoning Ordinance and Residential Planned Development No. 583, as amended, I hereby approve the foregoing minor change, but no other changes to Residential Planned Development No. 583 as amended.

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the R3 General Residence District and Residential Planned Development No. 583 symbols and indications as shown on Map Number 11-K in the area bounded by:

to those of Residential Planned Development No. 583, as amended.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Plan of Development Statements referred to in this ordinance reads as follows:

*Residential Planned Development No. 583, As Amended.*

*Plan Of Development Statements.*

1. The area delineated herein as Residential Planned Development No. 583 consists of a net site area of approximately 7.63 acres (332,491 square feet) which is owned by Columbia National Bank of Chicago, as Trustee under Trust No. 4974, Berteau Corporation, and Pal Group, Inc. ("Owners"). It is controlled by C.A. Development, L.L.C.

(the "Applicant") for purposes of this Residential Planned Development.

2. The Applicant shall obtain all applicable official reviews, approvals or permits which are necessary to implement this Plan of Development. Any dedication or vacation of streets or alleys or easements or adjustments of right-of-ways or consolidation or resubdivision of parcels shall require separate submittal on behalf of the Applicant or its successors, assignees or grantees in approval by the City Council. Prior to Part II approval the Applicant shall obtain approval necessary to assign official street addresses to all lots or units in the Planned Development.
3. The requirements, obligations and conditions within this Planned Development shall be binding upon the Applicant, its successors and assigns and if different than the Applicant, the legal title holder and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant, successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 11.11-1 of the Chicago Zoning Ordinance, the property, at the time applications for amendment, modifications, or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or under single designated control. Single designated control for purposes of this paragraph shall mean that any application to the City of any amendment to this Planned Development or any modification or change thereto (administrative, legislative or otherwise) shall be made by the Applicant for this Planned Development, or its successors and assigns, so long as future owners take subject to a Declaration of Covenants and Restrictions, which allow for the Applicant to make such amendments, including adding additional land to the Planned Development, or by the owners of all property within the Planned Development or any property owners association which is authorized to represent the owners as a single designated control entity.
4. This Plan of Development consists of these 16 Statements; a Bulk Regulations and Data Table; a Planned Development Boundary, Property Line and Map; an Existing Zoning and Land Use Map; a Site Plan-Overall Planned Development; a Site Plan with Typical Structures for Subareas A and B; a Site Plan with Typical Structures and Setbacks for Subareas C and D; Elevations for Townhomes for Subarea B; Elevations for Single-Family Homes for Subareas A, B, C and D Elevations for Townhomes for Subarea D, as prepared by Patrick Fitzgerald & Associates dated October 10, 1996 and Landscape Plans for Phase I and Phase II as prepared by Linden/Lenet Design Group dated October 10, 1996 which are all incorporated herein. A full size set for the Site and Landscape Plans

and Building Elevations are on file with the Department of Planning and Development. The Planned Development is applicable to the area delineated herein and no other zoning controls shall apply.

5. The following uses shall be permitted within the area delineated herein:
  - Subarea A: Detached single-family dwelling units, accessory parking and related uses.
  - Subarea B: Attached or detached single-family dwelling units, accessory parking and related uses.
  - Subarea C: Detached single-family dwelling units, accessory parking and related uses.
  - Subarea D: Attached or detached single-family dwelling units, accessory parking and related uses.
6. Project identification signs shall be permitted within the Planned Development subject to review and approval of the Department of Planning and Development. Temporary construction and marketing signs shall be permitted within the Planned Development subject to review and approval of the Department of Planning and Development. Temporary sales offices shall be allowed.
7. Any service drives or other ingress or egress including emergency vehicles shall be adequately designed, constructed and paved in accordance with the Municipal Code of Chicago and the regulations of the Department of Transportation in effect at the time of construction. There shall be no parking within such paved areas or within fire lanes. Ingress and egress shall be subject to the review of the Department of Transportation and the Department of Planning and Development. Private roads shall be subject to review by the Department of Transportation but are not required to meet public street construction standards.
8. Off-street parking shall be provided in compliance with this Plan of Development subject to review of the Departments of Transportation and Planning and Development. The minimum number of off-street parking spaces shall be determined in accordance with the attached Bulk Regulations and Data Table. On-street parking shall be permitted on one side of the private streets so designated on the Site Plan. The Applicant shall construct concrete publicly accessible sidewalks as shown on the Site Plan.

9. A covenant shall be recorded requiring all private streets to be improved to public street standards prior to any public street dedication. All easements as shown on the Site Plan shall be maintained by the Homeowner's Association which has been formed.
10. In addition to the maximum heights of buildings prescribed on the Building Elevations attached hereto, the height of any improvements shall also be subject to height limitations as approved by the Federal Aviation Administration.
11. The maximum permitted floor area ratio for the entire Planned Development area shall be in accordance with the attached Bulk Regulations and Data Table. Each subarea shall also be covered by the Bulk Regulations and Data Table. For purposes of F.A.R. calculations and floor area measurements, the definition in the City of Chicago Zoning Ordinance shall apply. After construction of any unit, the F.A.R. requirements of the R3 General Residence District shall apply to any individual unit.
12. Improvements of the property, including landscaping and all entrances and exits to the parking and private streets, shall be designed and installed in substantial conformance with the Bulk Regulations and Data Table, the Building Elevations and the Site Plans and the Landscape Plans attached hereto and made a part hereof. In addition, parkway trees and other landscaping shall be installed and maintained at all times in accordance with the Landscape Plan and the Parkway Tree Provisions of the Chicago Zoning Ordinance and correspondence regulations and guidelines.
13. All streets and alleys as noted on the Site Plan (including easement parcels) are private streets and alleys to be constructed by the Developer, and thereafter maintained by a Homeowner's Association which has been formed covering the entire property. Maintenance including snow plowing, paving and maintenance of underground utilities shall become the responsibility of the Homeowner's Association subject to a declaration of covenants and conditions which has been recorded against the subject property, and will be recorded against the Phase 2 property prior to any units being sold.
14. The terms, conditions and exhibits of this Planned Development ordinance may be modified, administratively, by the Commissioner of the Department of Planning and Development upon the application for such modification by the Applicant and after a determination by the Commissioner of the Department of Planning and Development, that such modification is minor, appropriate and is consistent with the nature of the improvements contemplated in this Planned Development. Any such modification of the

requirements of this statement by the Commissioner of the Department of Planning and Development shall be deemed to be a minor change in the Planned Development as contemplated by Section 11.11-3(c) of the Chicago Zoning Ordinance. Notwithstanding the provisions of subclauses 4 and 5 of Section 11.11-3(c) of the Chicago Zoning Ordinance, such minor changes may include a reduction in the minimum required distance between structures, a reduction in periphery set backs, an increase in the maximum percent of land covered, the change from attached to detached single-family units located in Subareas B and D, or subsequent set back reductions pertaining to individual residential units.

15. The Applicant acknowledges that it is in the public interest to design, construct and maintain all buildings in a manner which promotes and maximizes the conservation of energy resources. The Applicant shall use reasonable efforts to design, construct and maintain all buildings located within this Planned Development in an energy efficient manner consistent with the most current energy efficiency standards published by the American Society of Heating, Refrigerating and Air-Conditioning Engineers ("A.S.H.R.A.E.") and the Illuminating Engineering Society ("I.E.S."). Copies of these standards may be obtained from the Department of Planning and Development.
16. Unless substantial construction of the improvements within Subareas C and D contemplated by this Planned Development has commenced within ten (10) years following adoption of this Planned Development, and unless completion thereof is diligently pursued, then this Planned Development amendment shall expire with respect to those portions of the Planned Development; provided, however, that if the City Council amends the Chicago Zoning Ordinance to provide for a shorter expiration which is applicable to all planned developments, then this Planned Development shall expire upon the expiration of such shorter time period as provided by said amendatory ordinance (the first day of which is applied to this Planned Development shall be the effective date of the amendatory ordinance). If this Planned Development expires with respect to any portion of the property, then the zoning of Subareas C and D shall automatically revert to that of an R3 General Residence District and the remainder of the Planned Development shall revert to the Planned Development in existence prior to the date of this amendment.

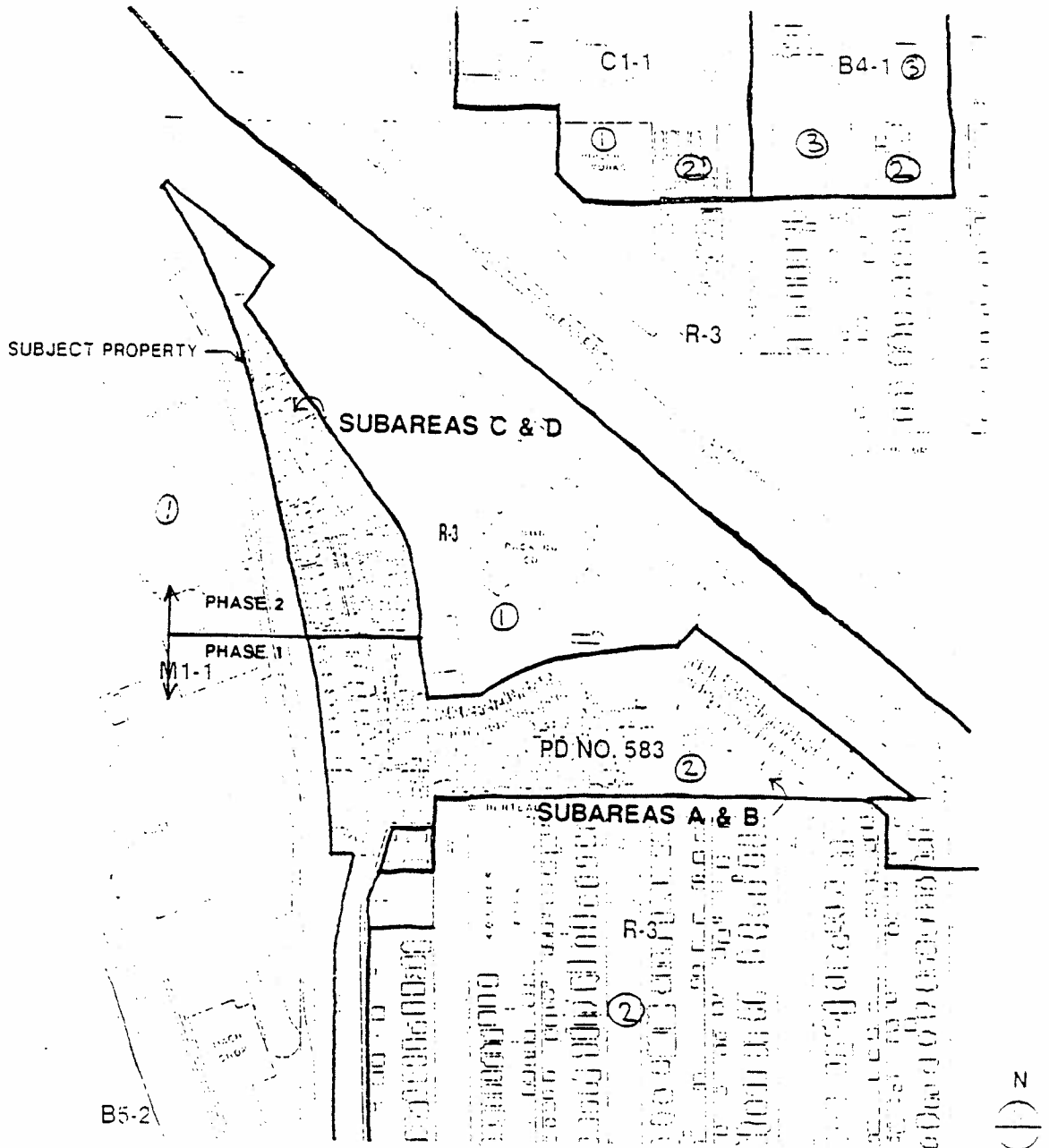

**EXISTING ZONING AND LAND USE MAP**

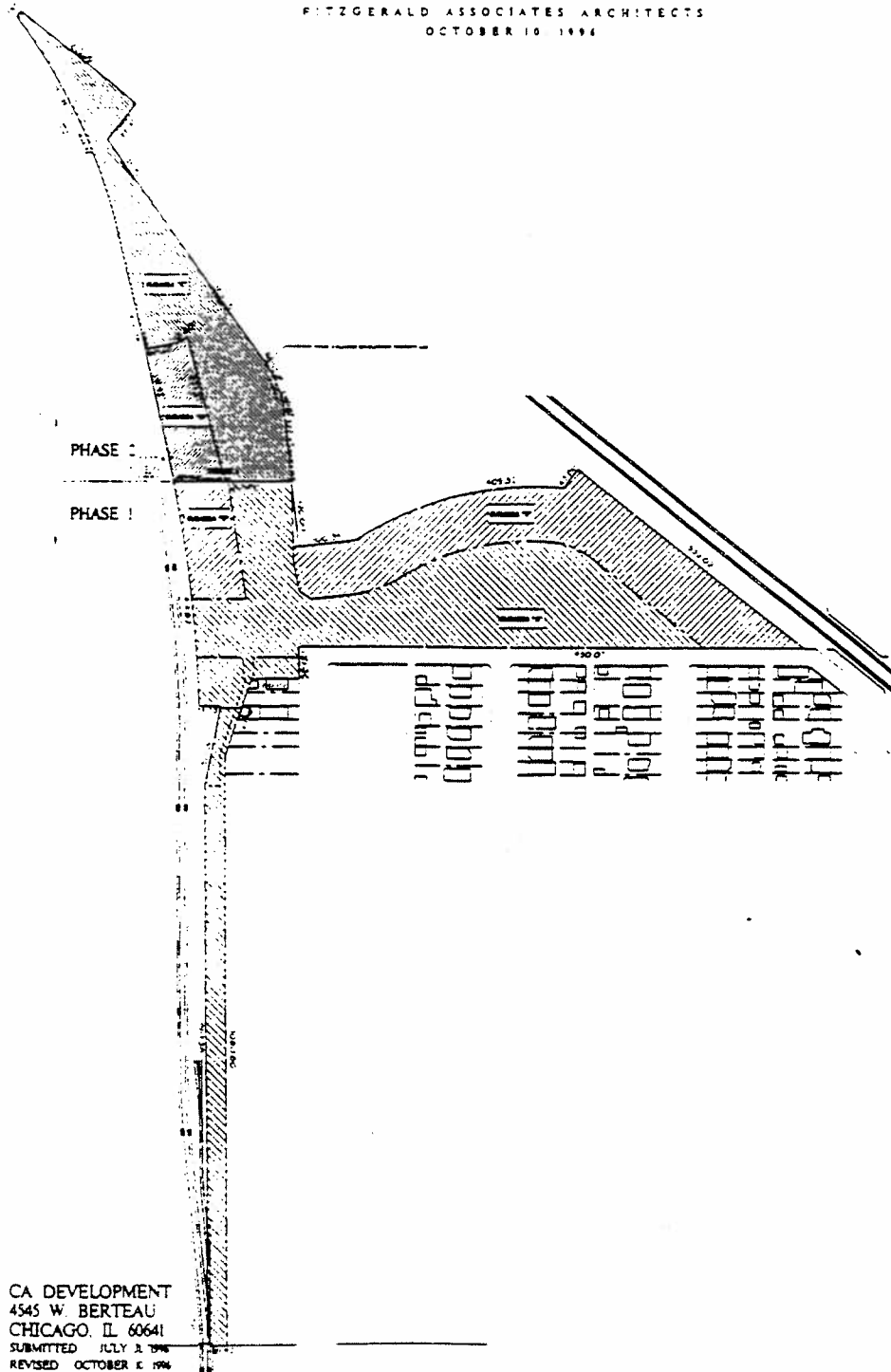

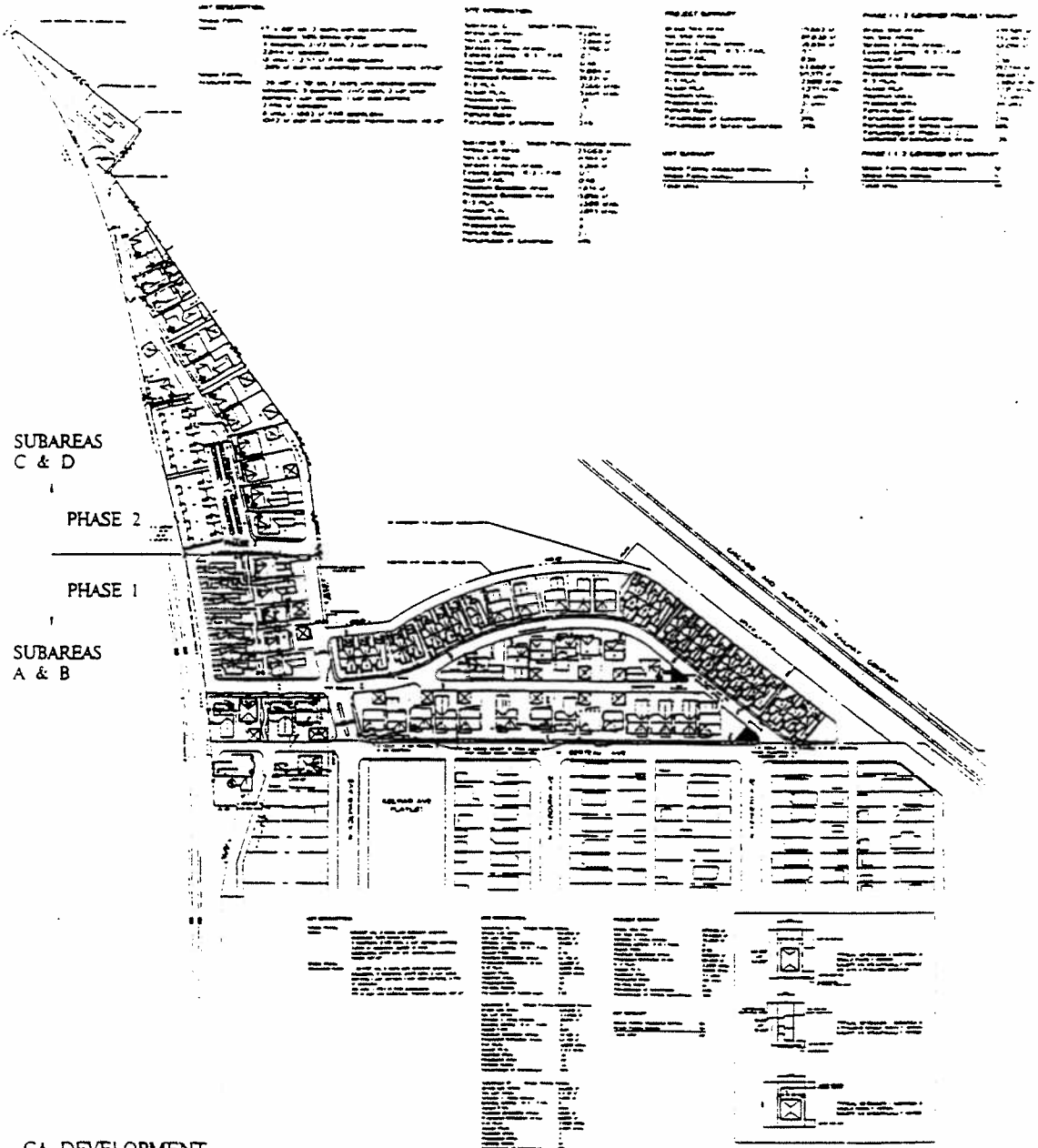

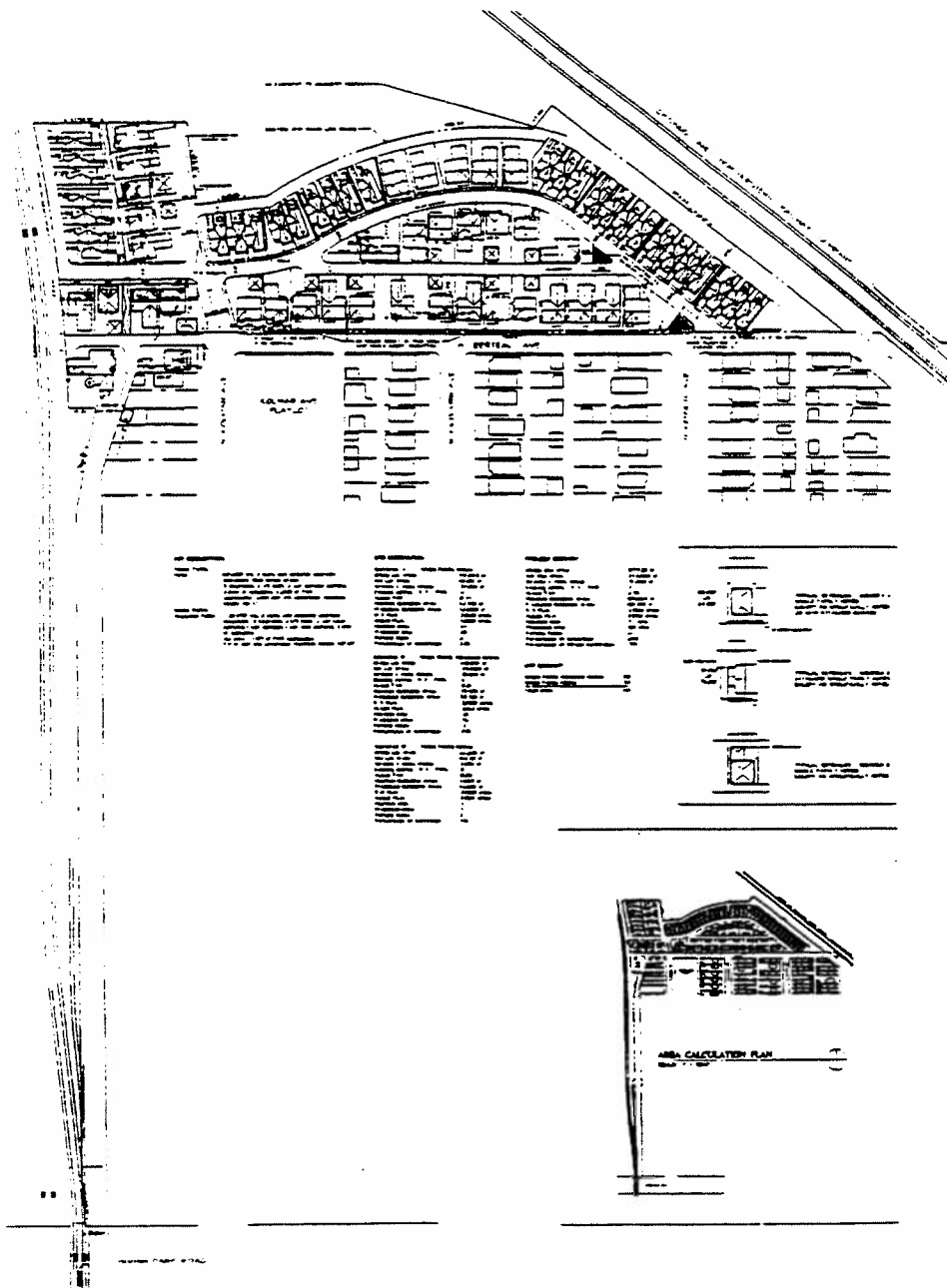

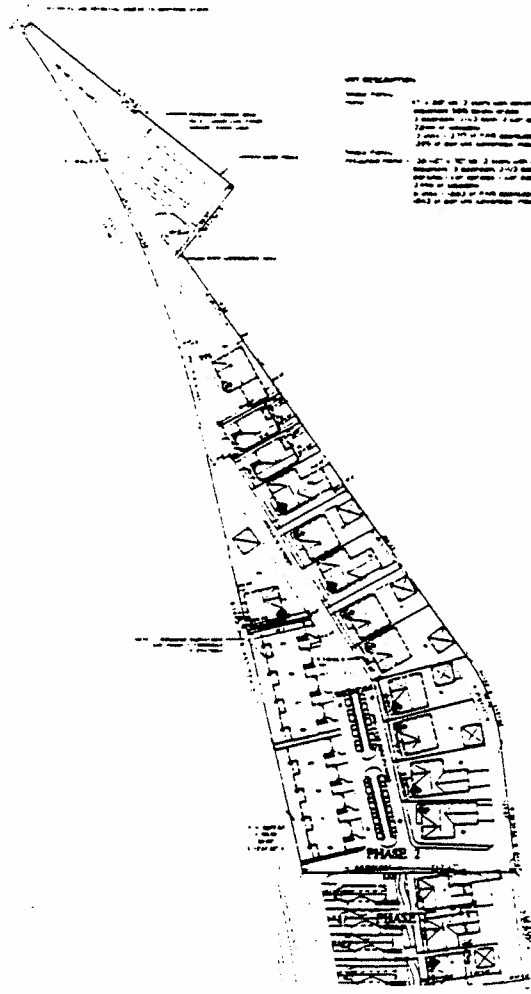

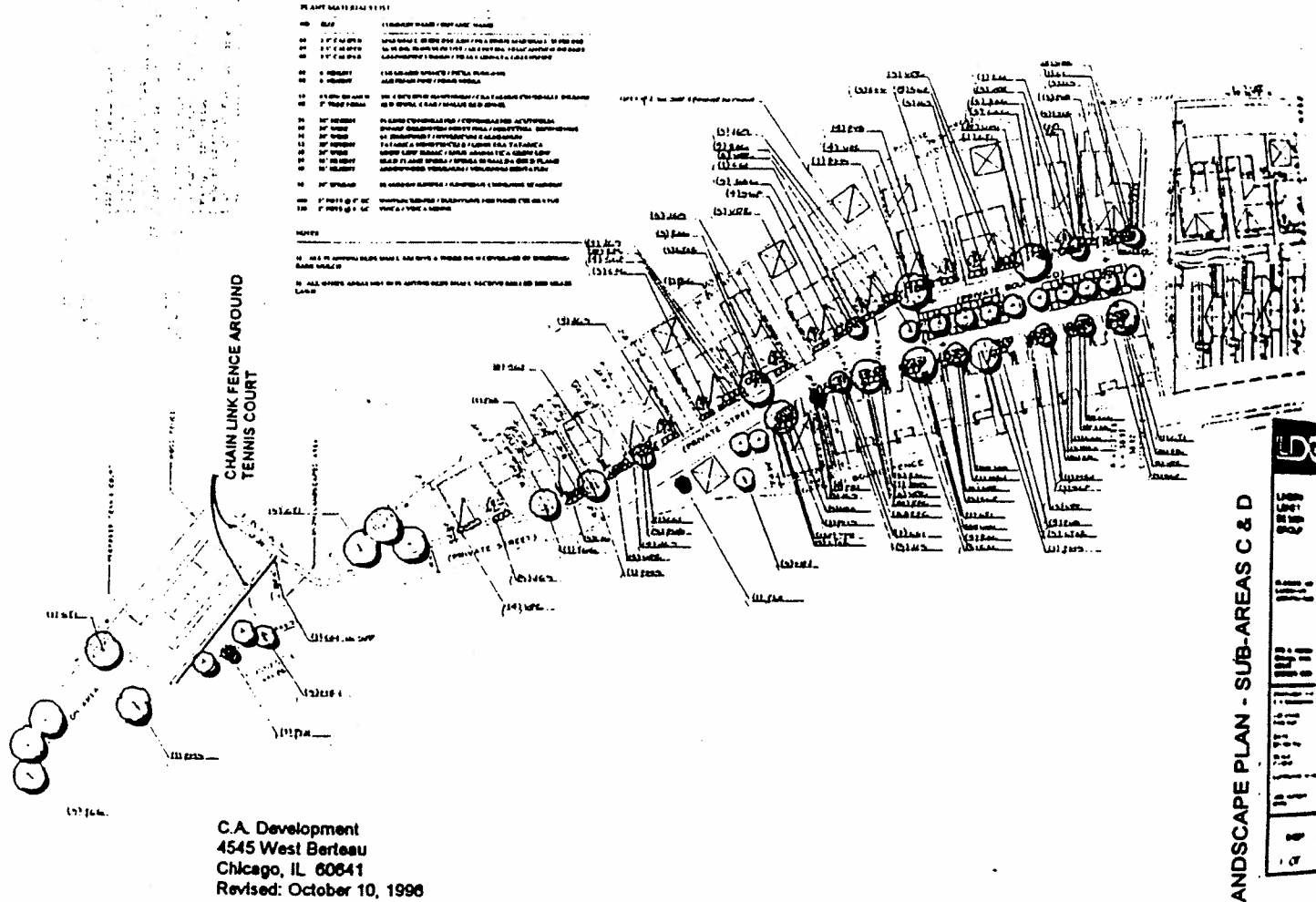

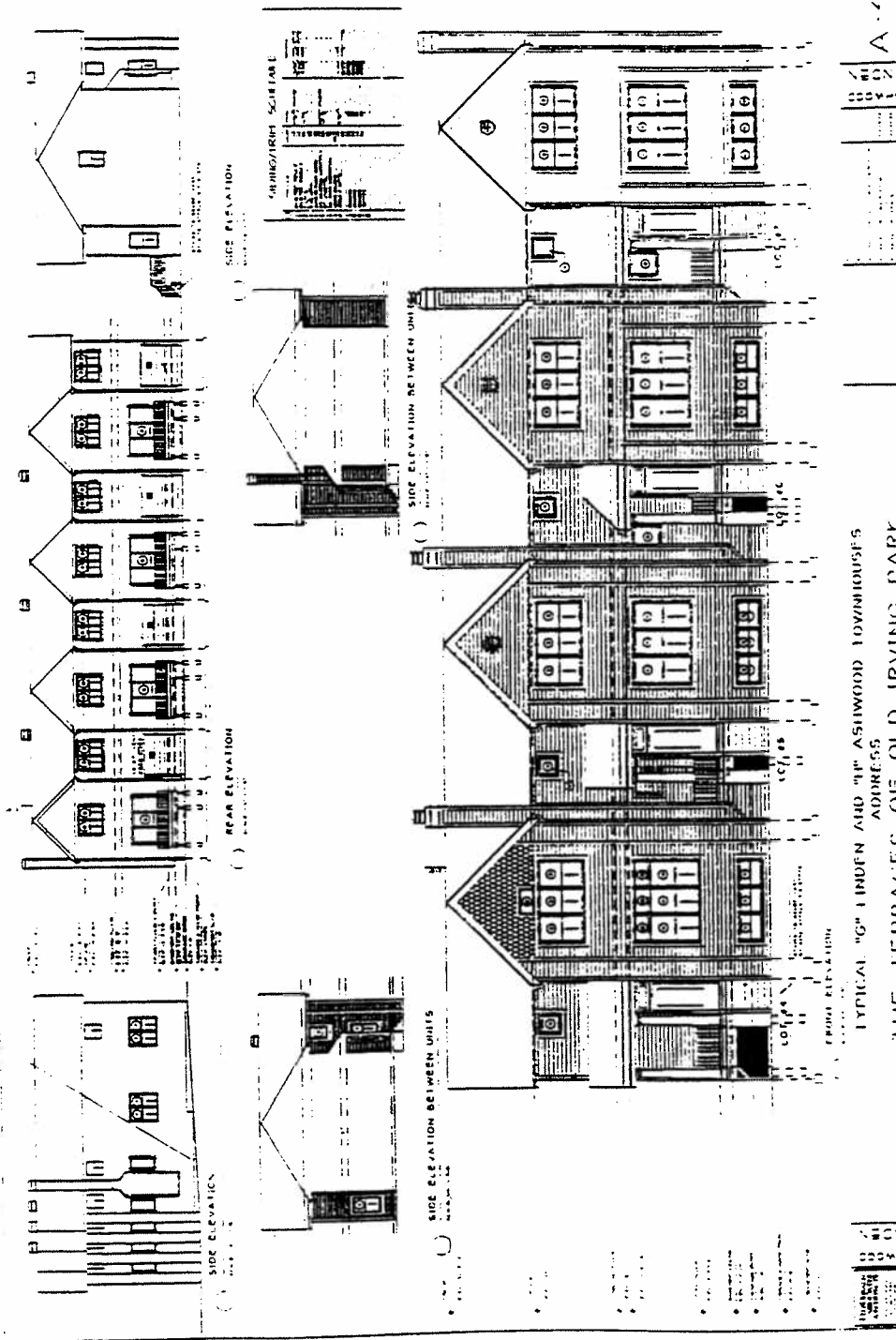

The following are said ordinances as passed (the italic heading in each case not being a part of the ordinance):

*Reclassification Of Area Shown On Map Number 11-K.*

*Be It Ordained by the City Council of the City of Chicago:* PD 583

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the R3 General Residence District symbols and indications as shown on Map No. 11-K in the area bounded by:

an east/west line starting at the east line of the Chicago & Northwestern tracks, said line being 304 feet north of and running parallel to the line of West Berteau Avenue, running east for a distance 217.47 feet; thence a north/south line running 120 feet south; thence an

east/west line running east and parallel to West Berteau Avenue, said line running east for 100.35 feet; thence a line with a length of 405.32 feet running along and parallel to the northerly line of the Chicago & Northwestern spur tracks; thence a line perpendicular to the Chicago & Northwestern railroad tracks running northeasterly 43.86 feet; thence a line running along the Chicago & Northwestern railway tracks running southeast for a distance of 532 feet ending at the north line of West Berteau Avenue; thence a line of West Berteau Avenue running west to the west line of North Kolmar Avenue; thence a line running south and perpendicular to West Berteau Avenue running south for 58.0 feet; thence a line running west and parallel to West Berteau Avenue for a distance 78.67 feet; thence a line running southwesterly along the Chicago & Northwestern track easement for a distance of 97.03 feet; thence a line running south and parallel to North Kolmar Avenue to the north line of West Irving Park Road; thence a line running west along the north line of West Irving Park Road for a distance of 31.92 feet; thence a line running north and parallel to the west line of North Kolmar Avenue for a distance of 969.38 feet; thence a line running northeasterly at an angle south by west of 10 degrees, 36 minutes, 9 seconds for a distance of 150 feet; thence a line running westerly to the Chicago & Northwestern tracks and parallel to the line of West Berteau Avenue for a distance of 79.73 feet; and thence a line running along and parallel to the Chicago & Northwestern tracks for a length of 414.82 feet to the point of beginning,

to those of a Residential Planned Development, as amended, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Plan of Development Statements referred to in this ordinance read as follows:

*Residential Planned Development, As Amended* PD 583

*Plan of Development Statements.*

1. The area delineated herein as a Residential Planned Development consists of a net site area of approximately 5.57 acres (242,663 square feet) which is owned by LaSalle National Bank & Trust Co., as Trustee under Trust Nos. 102239 and 105054, Berteau Corporation, and Pal Group, Inc. (the "Owners"). It is controlled by C.A. Development, L.L.C. (the "Applicant") for purposes of this Residential Planned Development.

2. The Applicant shall obtain all applicable official reviews, approval or permits which are necessary to implement this Plan of Development. Any dedication or vacation of streets or alleys or easements or adjustments of right-of-ways or consolidation or resubdivision of parcels shall require separate submittal on behalf of the Applicant or its successors, assignees or grantees in approval by the City Council. Prior to Part II approval the Applicant shall obtain approvals necessary to assign official street addresses to all lots or units in the Planned Development.
3. The requirements, obligations and conditions within this Planned Development shall be binding upon the Applicant, its successors and assigns and if different than the Applicant, the legal title holder and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant, successors and assigns and, if different that the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 11.11-1 of the Chicago Zoning Ordinance, the property, at the time applications for amendments, modifications, or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or under single designated control. Single designated control for purposes of this paragraph shall mean that any application to the City for any amendment to this Planned Development or any modification or change thereto (administrative, legislative or otherwise) shall be made by the Applicant for this Planned Development, or his successors and assigns, so long as future owners take subject to this pursuant to a Declaration of Covenants and Restrictions, which allow for the Applicant to make such amendments, including adding additional land to the Planned Development. Nothing herein shall be construed to mean that any individual owner or any ground lessors, of the property or any portion thereof, is relieved of obligations imposed hereunder or rights granted herein or is not subject to City action pursuant to this Planned Development. In addition, nothing herein shall prohibit or in any way restrict the alienation, sale, or any other transfer of all or any portion of the property or any rights, interests or obligations therein. Upon any alienation, sale or any other transfer of all or any portion of the property or the rights herein, except any assignment or transfer pursuant to a mortgage or otherwise as collateral for any indebtedness, and solely with respect to the portion of the property so transferred, the current application shall be deemed amended to apply to the legal title holder or transferee thereof (and its beneficiaries if such title is held in a land trust) and the seller or transferor thereof (and its beneficiaries if title is held in a land trust) shall thereafter be released from any and all obligations or liability hereunder.

4. This Plan of Development consists of these nineteen (19) statements: a Bulk Regulations and Data Table; a Planned Development Boundary and Property Line Map; an Existing Zoning and Land-Use Map; a Site Plan with Typical Structures; a Site Plan with Setbacks and Easements, and Building Elevations, as prepared by Patrick Fitzgerald & Associates, dated June 8, 1995; and Landscape Plans and Details, as prepared by Lenet Design Group, dated June 8, 1995, which are all incorporated herein. This Plan of Development is in conformity with the intent and purposes of the Chicago Zoning Ordinance (Title 17 of the Municipal Code of Chicago) and all requirements thereof and satisfies the establishment criteria for approval of a Planned Development. These and no other zoning controls shall apply to the area delineated herein.
5. The following uses shall be permitted within the areas delineated herein:
  - Subarea A: All residential uses permitted within the R3 General Residence District except for attached single-family and multi-family dwellings including accessory parking.
  - Subarea B: All residential uses permitted within the R3 General Residence District including townhouses and accessory parking.
6. Project identification signs shall be permitted within the Planned Development subject to review and approval of the Department of Planning and Development. Temporary construction and marketing signs shall be permitted within the Planned Development subject to review and approval of the Department of Planning and Development. Temporary sales offices shall be allowed.
7. Any service drives or other ingress or egress including emergency vehicles shall be adequately designed, constructed and paved in accordance with the Municipal Code of Chicago and the regulations of the Department of Transportation in effect at the time of construction. There shall be no parking within such paved areas or within fire lanes. Ingress and egress shall be subject to the review of the Department of Transportation, Bureau of Street Traffic and the Department of Planning and Development. Private roads shall be subject to review by the Department of Transportation, but are not required to meet public street construction standards.
8. Off-street parking and off-street loading facilities shall be provided in compliance with this Plan of Development subject to review of the Departments of Transportation and Planning and Development. The minimum number of off-street parking spaces shall be

- determined in accordance with the attached Bulk Regulations and Data Table. On-street parking shall be permitted on one side of the private streets so designated on the Site Plan. The Applicant shall construct concrete public sidewalks as shown on the Site Plan.
9. The Applicant shall extend Kolmar Avenue as shown on the Site Plan and it shall be constructed to public street standards. A Declaration of Easements and Restrictions shall be recorded on the property prior to Part II approval, whereby, upon request by the City, the Kolmar extension shall be dedicated as a public street. An additional covenant shall be recorded requiring all private streets to be improved to public street standards prior to any public street dedication. All easements as shown on the Site Plan shall be maintained by the Homeowner's Association which will be formed hereafter.
  10. The height restriction of any building or any appurtenance attached thereto shall, in addition to the Bulk Regulations and Data Table, be subject to:
    - (A) height limitations as certified on Form FAA-117 or successor forms involving the same subject matter, and approved by the Federal Aviation Administration; and
    - (B) airport zoning regulations as established by the Department of Planning and Development, the Department of Aviation and Department of Law and approved by the City Council; and
    - (C) the maximum height of buildings as shown on the elevations incorporated herein.
  11. The Planned Development herein shall be subject to the "Rules, Regulations and Procedures Related to Planned Developments", as promulgated by the Commissioner of the Department of Planning and Development and in effect on the date hereof.
  12. The maximum permitted floor area ratio for the entire parcel shall be in accordance with the attached Bulk Regulations and Data Table. Each subarea shall also be covered by the Bulk Regulations and Data Table. For purposes of F.A.R. calculations and floor area measurements, the definition in the City of Chicago Zoning Ordinance shall apply. After construction of any unit, the F.A.R. requirements of the R3 General Residence District shall apply to any individual unit.
  13. Improvements of the property, including landscaping and all entrances and exits to the parking and private streets, shall be

- designed and installed in substantial conformance with the Bulk Regulations and Data Table, the Site Plan and the Landscape Plan attached hereto and made a part hereof. In addition, parkway trees and other landscaping shall be installed and maintained at all times in accordance with the Landscape Plan and the Parkway Tree Provisions of the Chicago Zoning Ordinance and corresponding regulations and guidelines.
14. All streets and alleys as noted on the Site Plan (including easement parcels) shall be private streets and alleys to be constructed by the Developer, and thereafter maintained by a Homeowner's Association which shall be formed covering the entire property. Maintenance, including snow plowing, paving and maintenance of underground utilities shall become the responsibility of the to be formed Homeowner's Association subject to a declaration of covenants and conditions which shall be recorded against the subject property prior to the sale of any units thereof.
  15. The zoning restrictions which control the development of the subject property, shall be as set forth within these Planned Development Statements, the accompanying Bulk Regulations and Data Table, and the Site Plan, which sets out minimum setbacks and building lines. Further, the provisions of the Chicago Zoning Ordinance as to permitted variations, shall be allowed subject to the provisions set forth therein.
  16. The terms, conditions and exhibits of this Planned Development ordinance may be modified, administratively, by the Commissioner of the Department of Planning and Development upon the application for such modification by the Applicant and after a determination by the Commissioner of the Department of Planning and Development, that such modification is minor, appropriate and is consistent with the nature of the improvements contemplated in this Planned Development. Any such modification of the requirements of this statement by the Commissioner of the Department of Planning and Development shall be deemed to be a minor change in the Planned Development as contemplated by Section 11.11-3(c) of the Chicago Zoning Ordinance. Notwithstanding the provisions of sub-clauses 4 and 5 of Section 11.11-3(c) of the Chicago Zoning Ordinance, such minor changes may include a reduction in the minimum required distance between structures, a reduction in periphery set backs, an increase in the maximum percent of land covered, the change from attached to detached single-family units located in Subarea B, or subsequent set back reductions pertaining to individual residential units.
  17. The applicant acknowledges that it is in the public interest to design, construct and maintain all buildings in a manner which promotes and maximizes the conservation of energy resources. The applicant

shall use reasonable efforts to design, construct and maintain all buildings located within this Planned Development in an energy efficient manner consistent with the most current energy efficiency standards published by the American Society of Heating, Refrigerating and Air Conditioning Engineers ("A.S.H.R.A.E.") and the Illuminating Engineering Society ("I.E.S."). Copies of these standards may be obtained from the Department of Planning and Development.

18. Unless substantial construction of the improvements contemplated by this Planned Development has commenced within ten (10) years following adoption of this Planned Development, and unless completion thereof is diligently pursued, then this Planned Development shall expire; provided, however, that if the City Council amends the Chicago Zoning Ordinance to provide for a shorter expiration period which is applicable to all planned developments, then this Planned Development shall expire upon the expiration of such shorter time period as provided by said amendatory ordinance (the first day of which is applied to this Planned Development shall be the effective date of the amendatory ordinance). If this Planned Development with respect to any portion of the property expires under the provisions of the section, then the zoning of the portion of the property affected shall automatically revert to that of an R3 Single-Family Residential District. Substantial construction shall be considered to have commenced when the number of residential units completed equals or exceeds fifty percent (50%) of the total number of residential units permitted by the Planned Development.
19. The Applicant hereby retains the right within the terms of this amendment to make application for amendment to the Planned Development for unbuilt portions or to add additional land for development consistent with the Planned Development as approved. Pursuant to the terms of this paragraph, the requirements under the Chicago Zoning Ordinance for sole ownership and control of the land within the Planned Development, even if individual residential units have been sold.

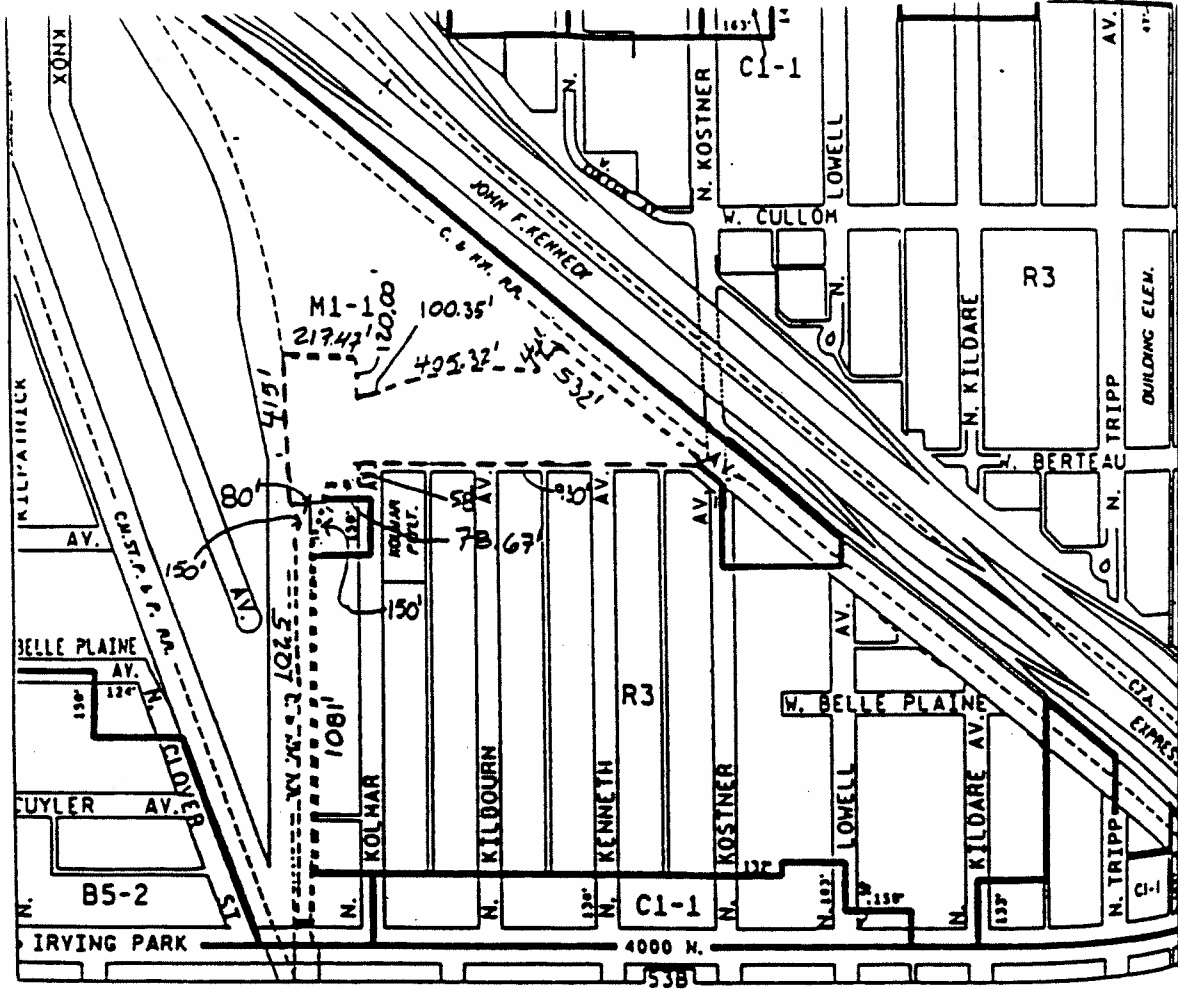

### Planned Development Boundary And Property Line Map.

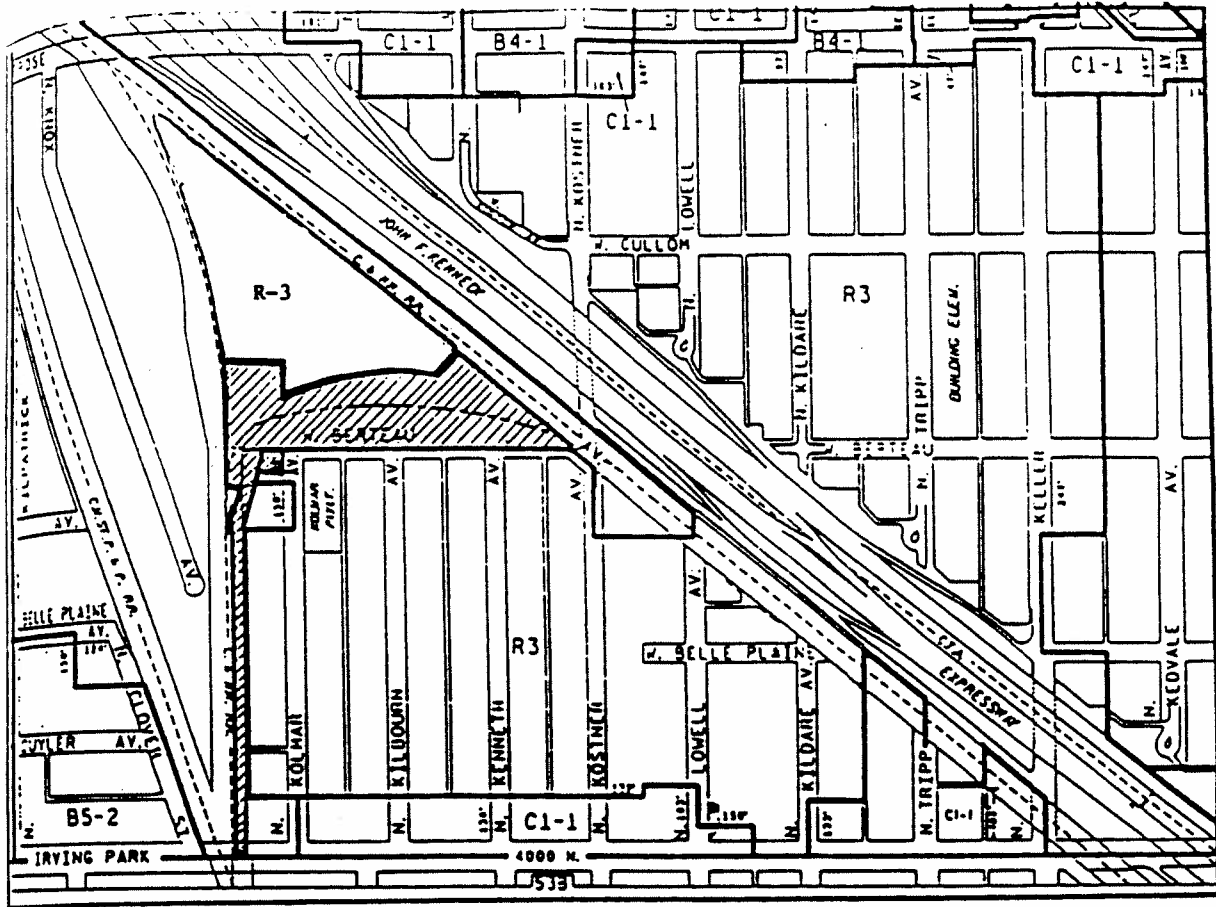

Existing Zoning And Land-Use Map.



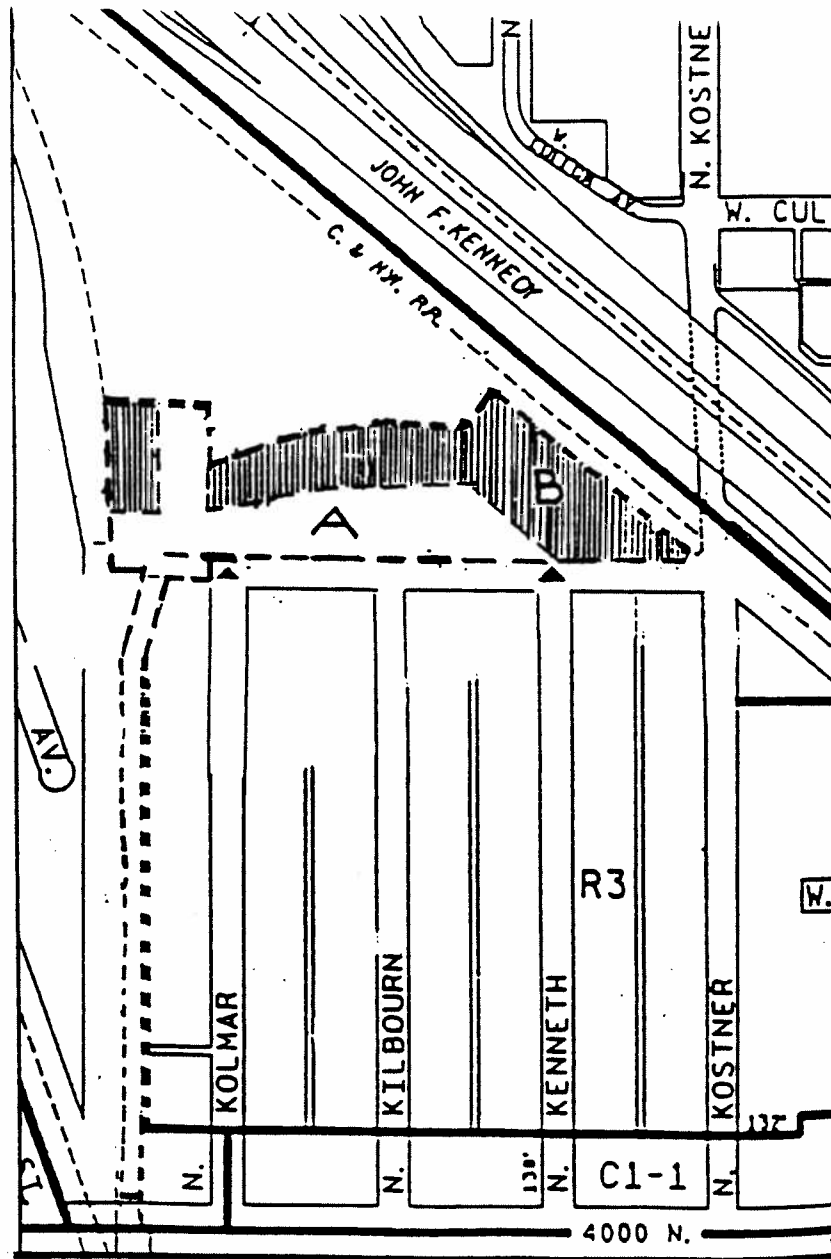

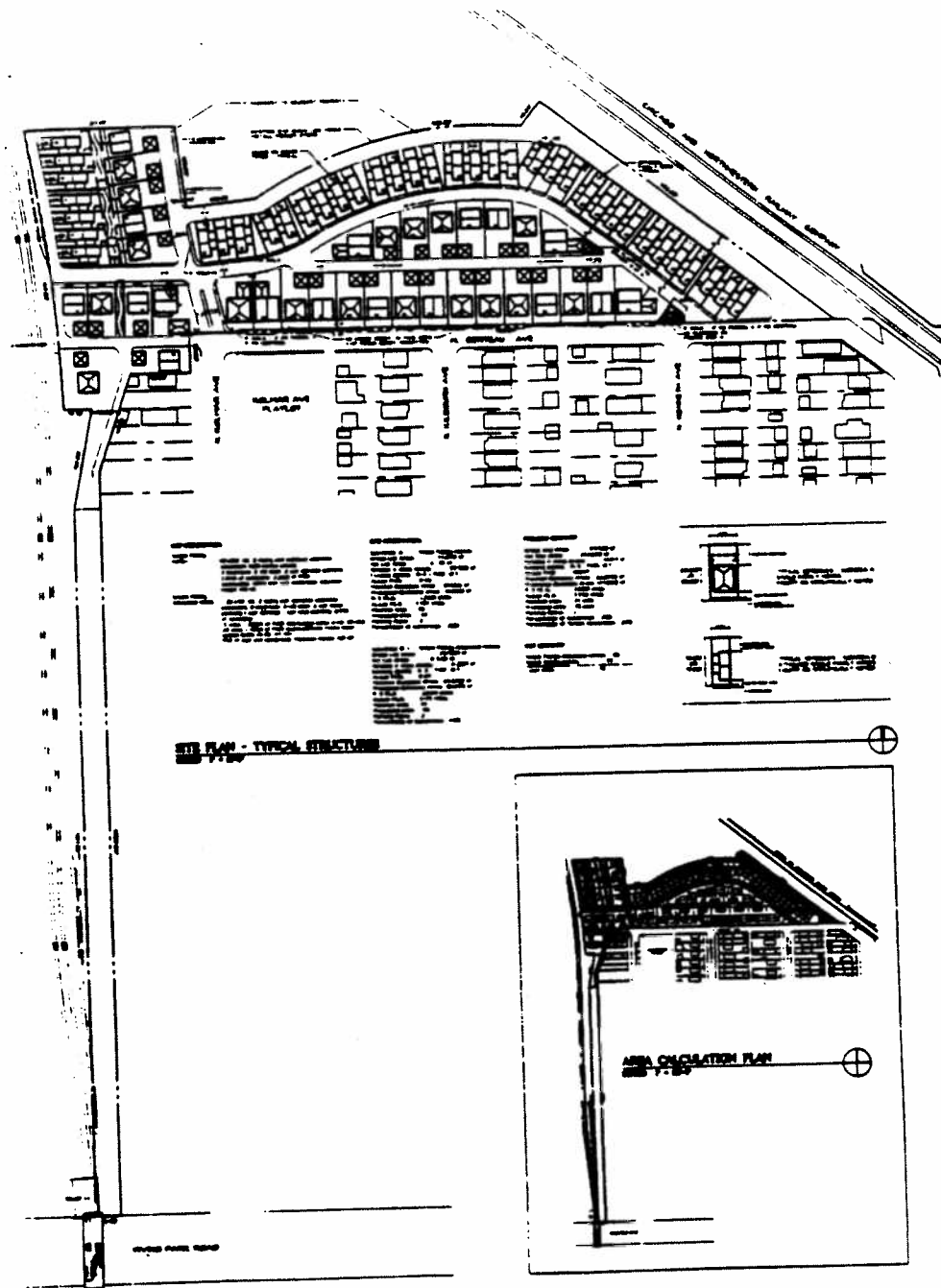

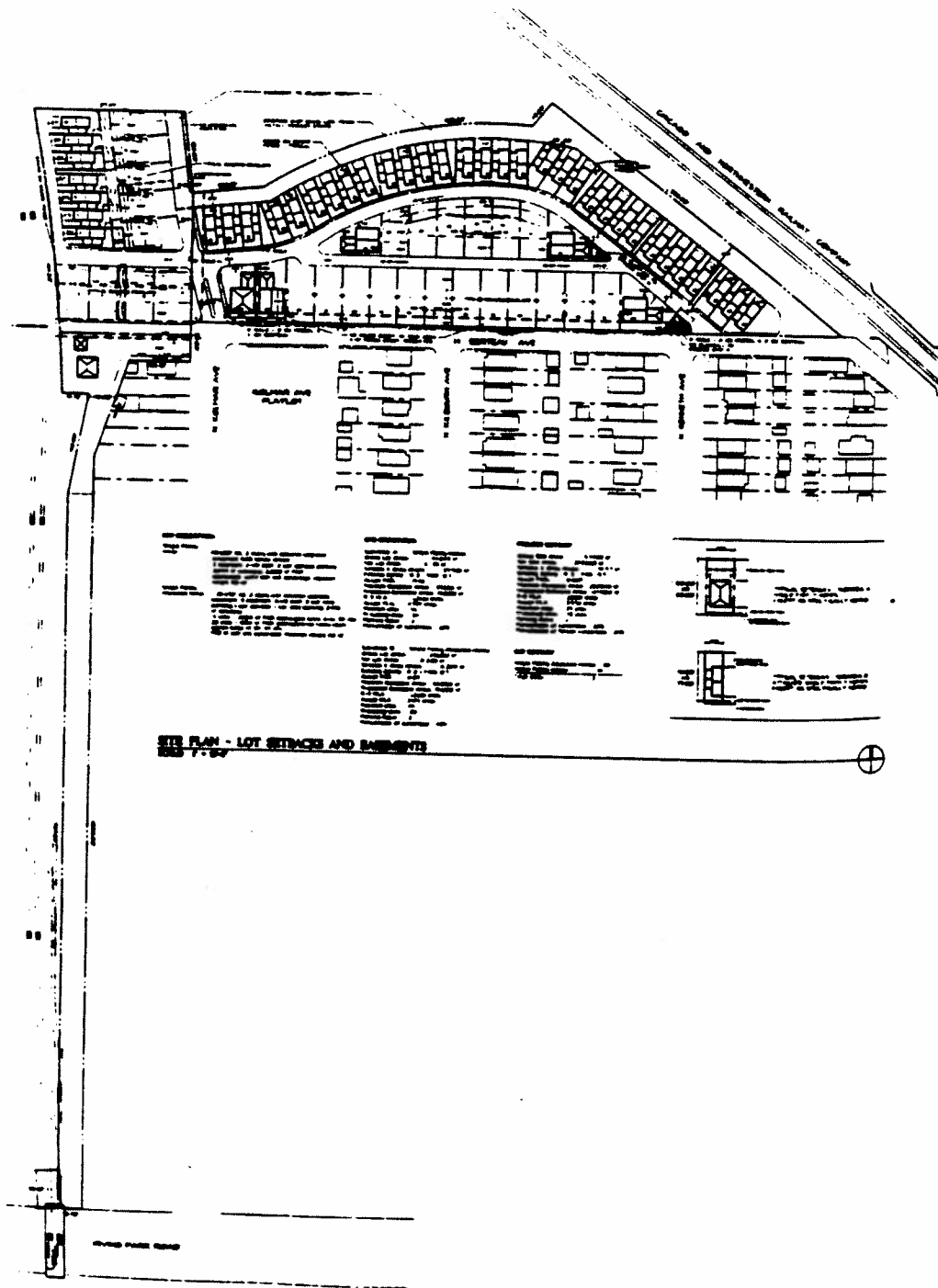
### Site Plan With Typical Structures.

Planned Development Boundary And Property Line Map.

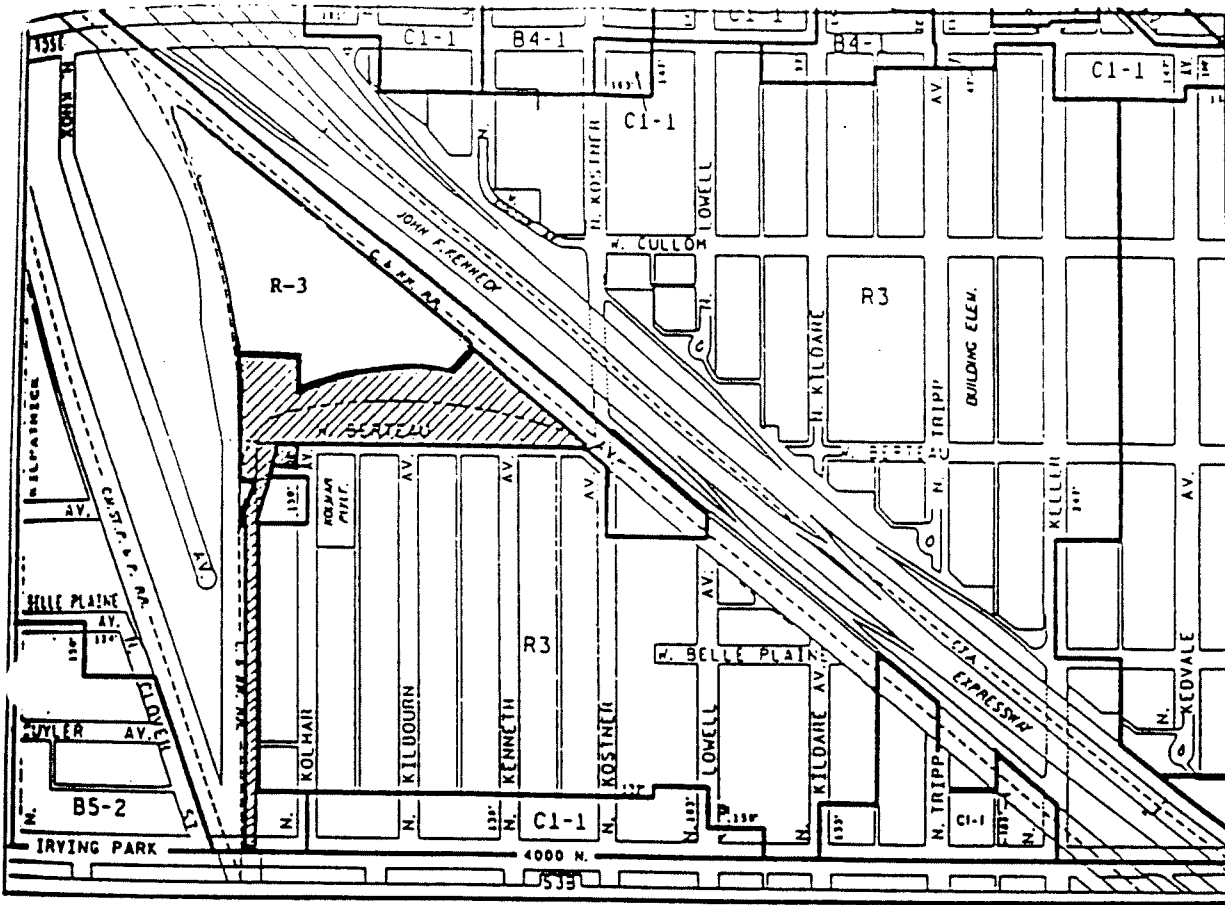

Existing Zoning And Land-Use Map.



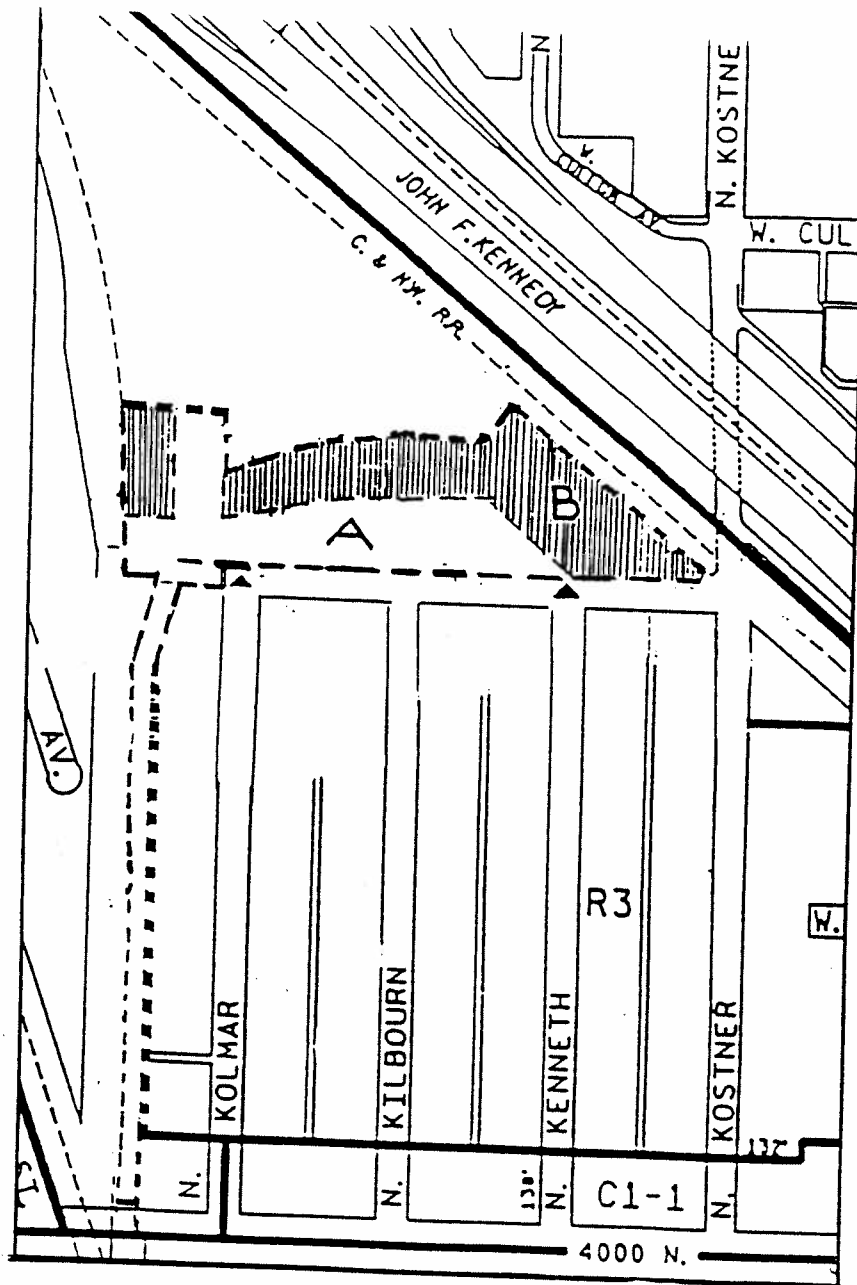

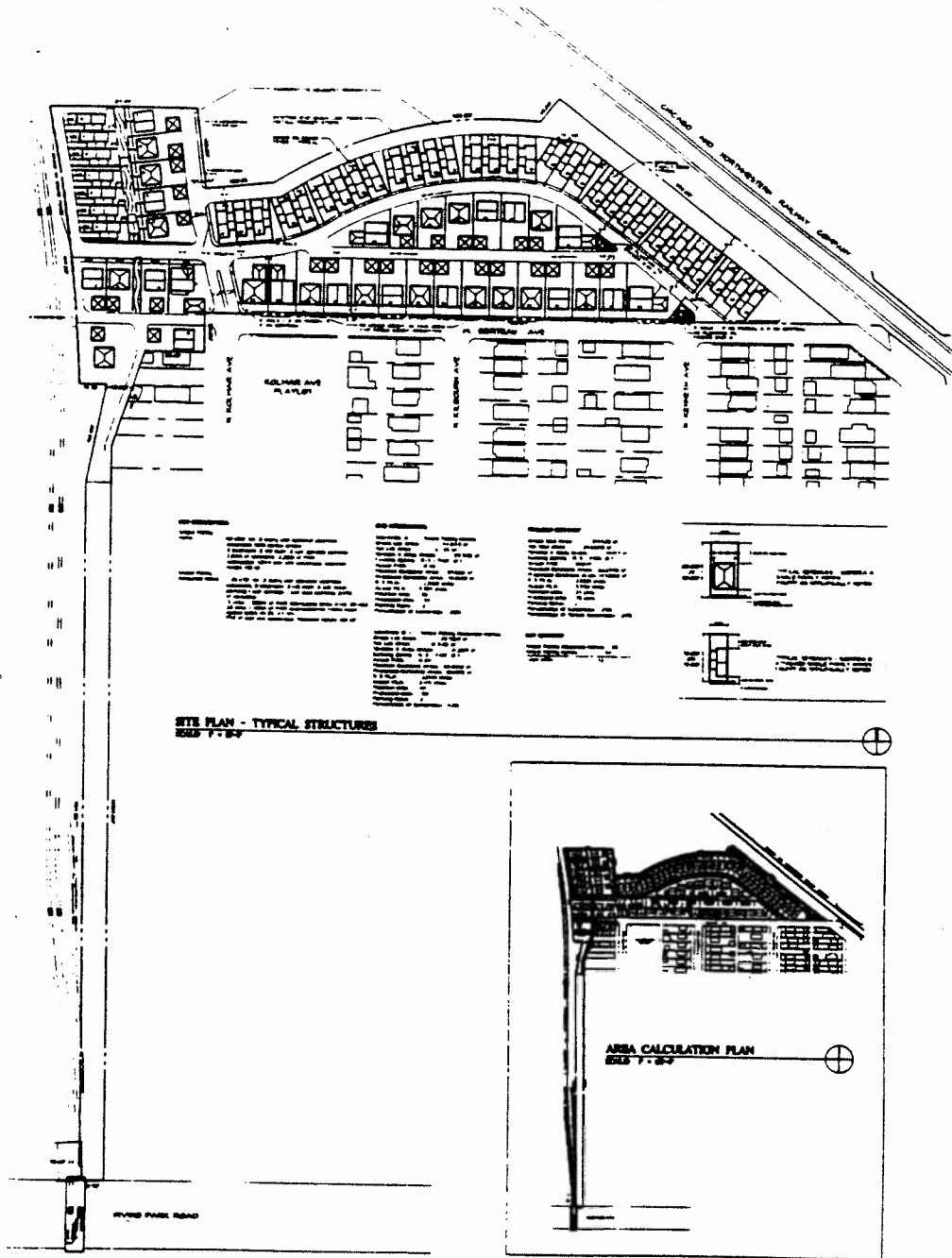

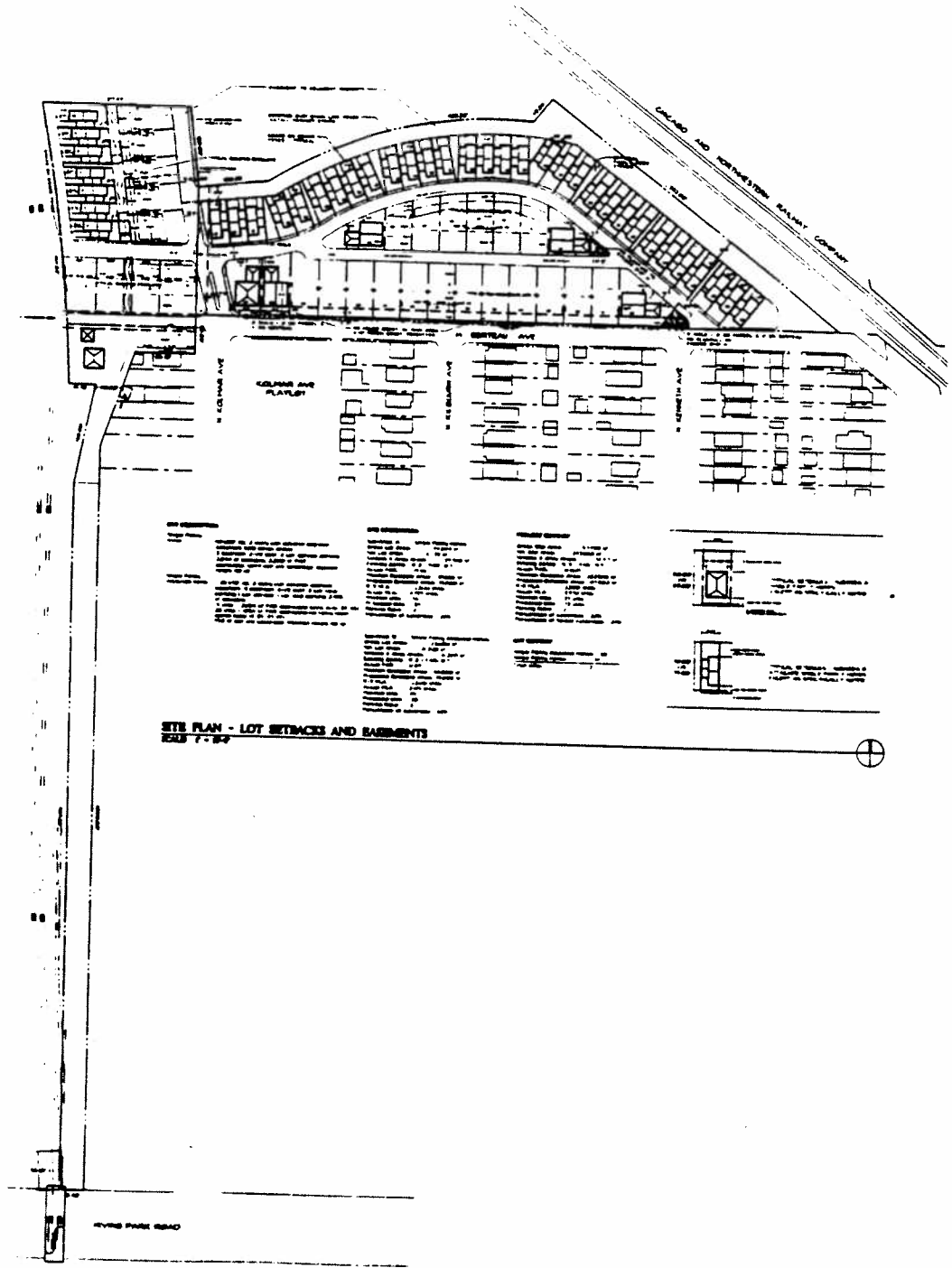
### Site Plan With Typical Structures.

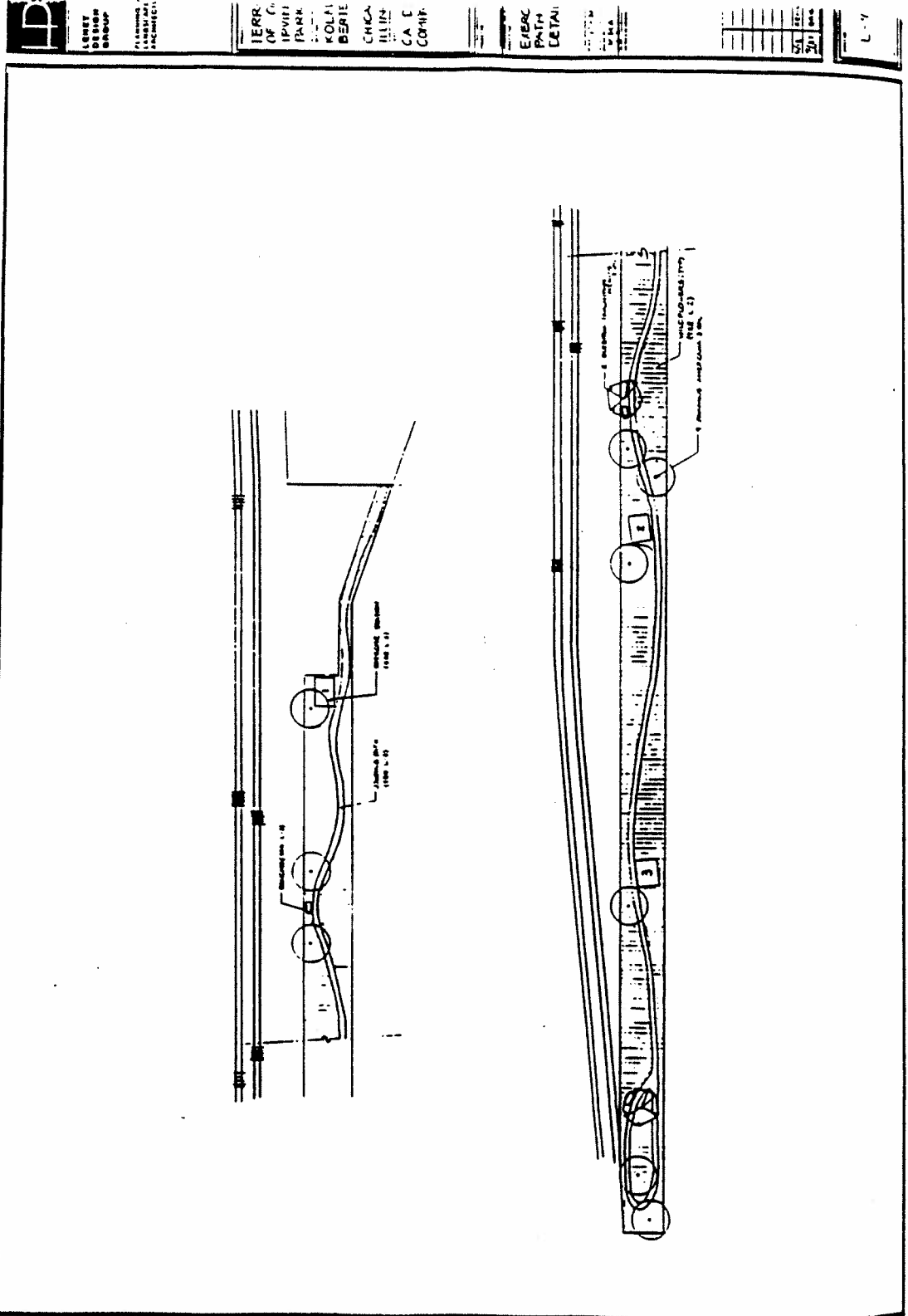

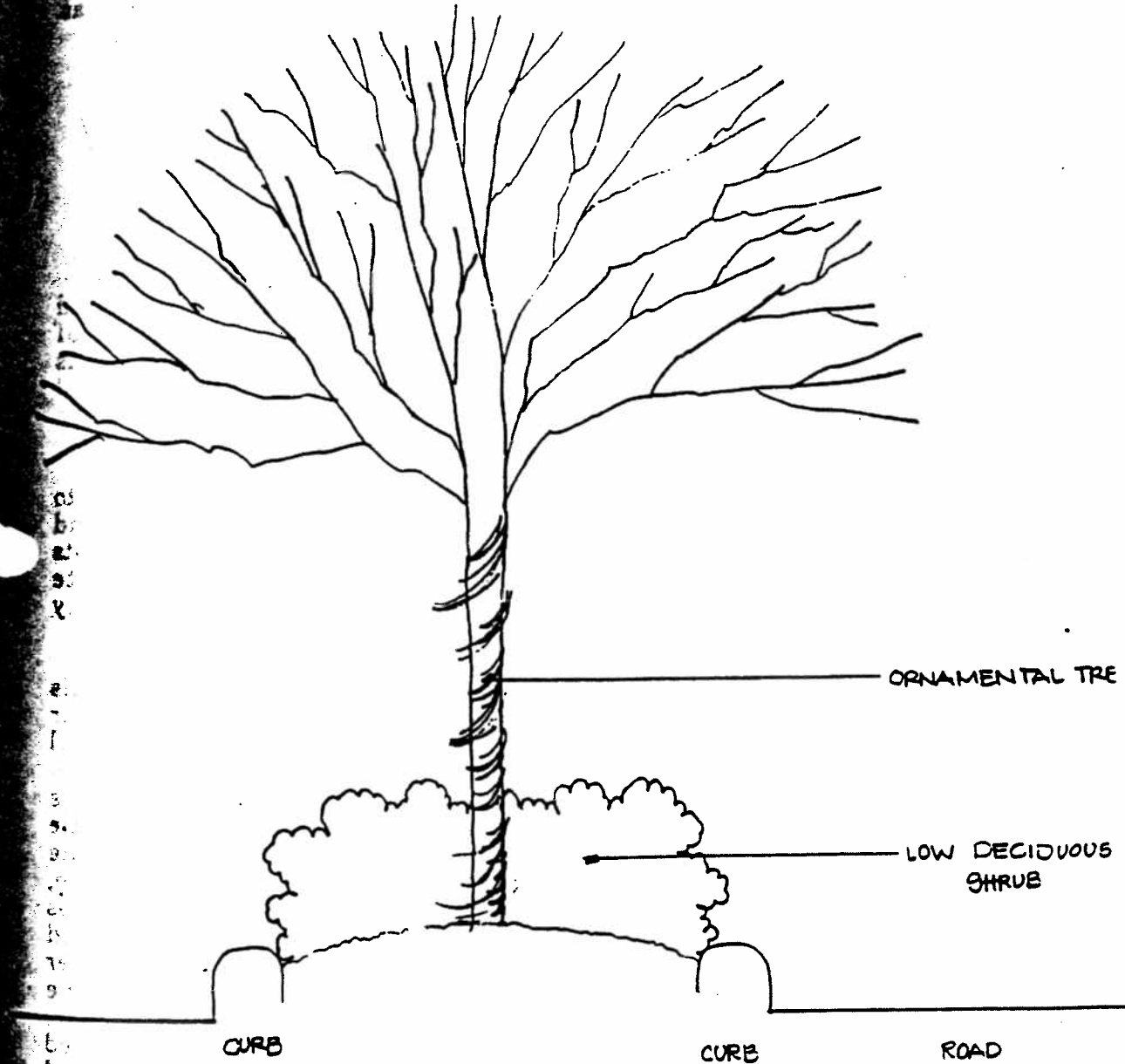
